The Forest Park Women's Club would like to invite you to participate in the 2010 Craft Show and Bazaar

DATE: October 30, 2010 – Set-up time is Saturday, October 30, 2010, 7:30 a.m. – 10:00 a.m. **THE DAY OF THE SHOW.** To avoid congestion, please unload, **PARK AWAY FROM THE BUILDING,** and then set up.

HOURS: 10:00 a.m. – 3:00 p.m., Saturday October 30, 2010. Show time starts promptly at 10:00 a.m. and you must stay until closing time.

BOOTH SPACE: Approximately 8 ft. x 8 ft. for one preassigned space. **YOU MUST PROVIDE YOUR OWN DISPLAY AND TABLE(s)** Two chairs per booth will be provided. Spaces will be assigned as applications are received. All tables must be skirted by each crafter.

ENTRY FEE: \$30 for one booth space for the one-day show for past participants. **THE \$30 FEE MUST BE RECEIVED WITH THE APPLICATION BY JUNE 1, 2010.** If the application is received after June 1, 2010, the fee is \$35, same as the fee for new participants. Booth rental refund will only be given if cancellation notification is received by October 1, 2010 or if the booth can be rented to someone on our waiting list.

RAFFLE DONATION: FPWC sponsors a cash first prize at its craft show raffle. Crafters are welcome to donate additional items to the raffle.

LIABILITY: In connection with the use of the space reserved and participation in FPWC Craft Show and Bazaar 2010, the exhibitor hereby agrees to expressly indemnify and hold forever harmless the Forest Park Women's Club and Winton Woods High School from and against all suits, claims, damages, loss or damage to property, sustained while on the school grounds, occasioned by any act, omission, neglect or wrongdoing of exhibitor his/her agents or employees. Insurance must be carried by the exhibitor if personal property is to be covered.

Exhibitor also understands that this contract is not a lease, but represents conditional permission to use certain space at the FPWC Craft Show and Bazaar 2010. If anything causes cancellation of the craft show, this contract becomes void, and refunds will be made on any fee received prior to cancellation.
